Resolution of Advisory Neighborhood Commission 4D Establishing a Task Force for Public Safety

Advisory Neighborhood Commission 4D (ANC 4D) takes note of the following:

1. **WHEREAS** public safety is a matter of significant ongoing concern and must be addressed through a holistic approach that addresses the underlying conditions that either promote or deter criminal activity;
2. **WHEREAS** ANC4D wishes to develop specific, concrete ideas for addressing neighborhood concerns related to public safety;
3. **WHEREAS** ANC 4D wishes to capitalize on the experience, creativity, and collective wisdom of the community of 4D;

THEREFORE, BE IT RESOLVED, that Advisory Neighborhood Commission 4D establishes a Task Force for Public Safety, which shall be organized as follows:

1. The Task Force shall be chaired by ANC Commissioner Anthony Pirrotti;
2. The size and membership of the Task Force shall be determined by Commissioner Pirrotti, and shall include both elected ANC commissioners

and members of the public;

3. The Task Force shall examine problematic areas of crime within ANC 4D and develop a list of specific recommendations for the Commission to consider;
4. The Task Force shall consider a wide arrange of ideas, including policy changes, recommendations for policing, and the redesign of public spaces;
5. The Task Force shall conclude its work no later than December 31, 2023 and shall present its findings at the ANC meeting to be held January 17, 2024.

This resolution was considered on October 18, 2023 before ANC 4D at a duly announced meeting of the Commission in the presence of a quorum.

The vote of the Commission was 7 in favor, 0 against, and 0 abstentions.

The resolution is hereby adopted as resolution number 4D-2023-14.
