**RESOLUTION OF ADVISORY NEIGHBORHOOD COMMISSION 4D CONCERNING  
THE INSTALLATION OF A SECURITY CAMERA AT 5000 NEW HAMPSHIRE AVENUE  
NW**

Advisory Neighborhood Commission 4D takes note of the following:

1. **WHEREAS** the safety and well-being of our residents are of paramount importance,
2. **WHEREAS** there has been an increase in criminal activities and safety concerns within our community, particularly in the area around the shopping center on the 5000 block of New Hampshire Ave NW, including three recent shootings resulting in two murders,
3. **WHEREAS** ANC4D unanimously voted on September 20, 2023 to request that MDP increase video surveillance at this same location ([ANC Resolution 4D-2023-10](#)), and
4. **WHEREAS** residents from the 4900 block of New Hampshire Avenue and business owners from the 5000 commercial block of New Hampshire Avenue have submitted a petition to MPD requesting that a CCTV camera be installed near the 100 block of Farragut Street and the 5000 block of New Hampshire Avenue,

**THEREFORE, BE IT RESOLVED That Advisory Neighborhood Commission 4D:**

1. Encourages MPD to accede to the community's request for increased surveillance at this location, and
2. Urges MPD to install a surveillance camera or similar technology at this location as soon as possible.

**BE IT FURTHER RESOLVED That Commissioner Anthony Pirrotti (4D08) is hereby authorized to represent the Commission in all matters relating to this resolution.**

This Resolution of Advisory Neighborhood Commission 4D was considered on October 18, 2023 before ANC 4D at a duly noticed meeting of the Commission in the presence of a quorum.

The vote of the Commission was 7 in favor, 0 against, and 0 abstentions. The resolution is hereby adopted as resolution number 4D-2023-15.
